BRIAN HAUF

Unit 135

I am Brian Hauf, applying for a director position on the DMC Board of Directors. I support the current Board, the General Manager's administration, DMC policy, procedures and practices. DMC has important issues pending, e.g., forestation, utilities, financial security; its monthly operational decision requirements require continued attention and overview.

I was raised in a farming community in Wyoming. My family moved in search of a better quality of life when I was 7, ending in Berkeley, CA, but settling in San Jose. I almost graduated with a "premed" B. S. degree at San Jose State College in 1964. Vietnam terminated single men college deferments that year. I joined the Air Force after spring term testing, selecting medic training. During basic training, an additional medical exam was conducted. Being 1 of 16 out of 64 to pass a Class A pilot physical, my planned technical training was changed to Air Traffic Control. This changed my employment direction for the next 36 years. During transition to the war theater, I was reassigned to Guam as a Tower Controller. After that 18-month duty tour, I was assigned to Travis Air Force Base to be trained as a Terminal Radar Approach Controller.

I married in 1967 to a woman I met on a blind date in 1965 (Marti-who yet remains with me). I exited the Air Force in 1968, with immediate employment in the Federal Aviation Administration (FAA) at the Oakland Airport air traffic control

tower. After 2 years, I was promoted, then certified as a Radar Approach Controller, a new control facility located at Oakland Airport. During the next 17 years, I was promoted from controller to staff positions, then 1st and 2nd line supervisor. In 1987, and the subsequent 10 years, I was promoted to supervisor positions at the Oakland Air Route Traffic Control Center, Fremont, CA, ending as Assistant Manager for Airspace and Procedures.

After FAA retirement in 1997, I was employed by the Aviation Safety Reporting System, NASA Ames Research Center, Sunnyvale, CA. Within 1 year I became a Project Manager with a \$7.35 million annual budget. We also conducted bi-annual briefings to the U. S. Congress' aviation sub committees on trends, improvements, failures and incidents anywhere U.S. commercial contract carriers conducted flight operations. I held this position for another 6 years prior to my 2nd retirement.

Marti and I purchased Unit 135 in DMC on October 2019. DMC needs to continue its progress development with openness, accountability and conservative management. I therefore submit my application for consideration.

I am a business attorney, but my wife says I am not the kind you want to see at the bottom of the Pacific Ocean or she would not have dated me.

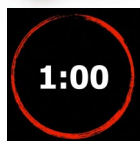
Graduating from the University of Michigan Law School, I have practiced law in California for over 50 years, co-founding and serving as the CEO of a Silicon Valley Law firm.
